## MERCHANT SHIPPING ACT 2001



### NOTICE OF MORTGAGE INTENT

- If more than one mortgagor (borrower) then a separate form is required unless shares are held jointly.
- The notice of mortgage intent is recorded on the Register for a period of 30 days unless it is withdrawn within that time.
- The notice may be renewed or further renewed for a period of 30 days, by notice in writing to the Registry. The relevant fee is required each time.
- Section 1 must be completed if the ship is currently registered in the BVI.
- Section 2 must be completed if the ship is not currently registered in the BVI.
- Section 3 and 4 must be completed in all cases.
