### ENACTED by the Legislature of the Virgin Islands as follows:

Section 2 amended. Cap. 203	-	The Cruising Permit Ordinance (hereinafter referred to in this Act pal Ordinance") is amended in section 2 by inserting in appropriate quence the following definitions:	
	"foreign based charter boat" means any charter boat other than a home based charter boat;		
	"home based charter boat" means a charter boat		
		(a) operating in the Virgin Islands;	

- (b) generally maintained in the Virgin Islands; and
- (c) managed by a company or any other legal entity incorporated, registered or licensed in the Virgin Islands,

for a period of five (5) months or more in any twelve month period.".

**3.** Section 4 of the principal Ordinance is amended by inserting Section 4 immediately after the word "Schedule", the words "in respect of home based charter boats and foreign based charter boats".

**4.** Section 5 of the principal Ordinance is amended by replacing the words "charter boat based in the Territory." with the words "home based charter boats.".

5. Section 5A of the principal Ordinance is amended in subsection (1) Section 5A by replacing the words "charter boat not based in the Territory" with the words "foreign based charter boat".

6. The principal Ordinance is amended by deleting section 11 and replaced. Section 11 replaced.

"11. A ferry as defined under section 2 of the British Act No. 12 of Virgin Islands Ports Authority Act, 1990, shall not be subject to <sup>1990</sup>

7. The principal Ordinance is amended by inserting after section 14 Insertion of the following new section:

"Power to amend Second Schedule. **14A.** (1) With the approval of Cabinet, the Minister may, by Order published in the *Gazette* and a newspaper of wide circulation in the Territory, amend the Second Schedule of this Ordinance."

(2) An Order made under subsection (1) shall be subject to a negative resolution of the House of Assembly.".

**8.** The Second Schedule to the principal Ordinance is replaced with the following:
