- OUT OF WATER INSPECTION
- STABILITY INFORMATION – *6 MONTHS TO RESOLVE*
- SHIP STATION LICENSE
- MEANS OF CLOSURE FOR ENGINE SPACE
- EMERGENCY EXITS LABELED
- EMERGENCY FUEL SHUTOFF VALVE OUTSIDE ENGINE SPACE (VALVE TO BE LABELED)
- EMERGENCY LIGHTING (FLASH LIGHTS ECT.)
- EMERGENCY AERIAL – EXEMPT/WAIVE CONDITONAL CAT. 4 WATERS
- EMERGENCY STEERING ARRANGEMENTS
- HIGH WATER BILGE ALARM (VISUAL AND AUDIBLE)
- PROPANE DETECTOR - *EXEMPT/WAIVE WHERE NO PROPANE IS ONBOARD*
- SMOKE DETECTORS FITTED IN ALL SPACES WHERE REQUIRED
- DAY SHAPES - *EXEMPT/WAIVE CONDITONAL CAT. 4 WATERS*
- MAGNETIC COMPASS
- NAUTICAL CHARTS OF OPERATING AREA
- ANCHORS (MAIN AND SECONDARY)
- LIFE RAFT OR ANY APPROVED APPLIANCES (EG. BUOYANT APPARATUS, LIFE BUOY (1 PER PERSON), DINGY)
- (2) LIFE BUOY WITH RETRO-REFLECTIVE TAPE AND NAME OF VESSEL (CIRCULAR/HORSESHOE) (1)WT. LIFEBOUY LIGHT (1) WT. BUOYANT LINE FOR BUOY (60')
- DAN BUOY (SAILING VESSEL ONLY)
- TYPE 1 LIFEJACKETS WITH RETRO-REFLECTIVE TAPE, LIGHTS, WHISTLES AND NAME OF VESSEL (1 PER PERSON)
- CHILDREN LIFEJACKET
- DISTRESS FLARES

- FIRE EXTINGUISHERS FOR ENGINE AND ACCOMMODATION SPACES (MUST BE TAGGED)
- (2) FIRE BUCKET (MUST BE LABELED FIRE)
- FIRE BLANKET (FOR GALLEY)
- EMERGENCY ACTION CARD – INDUSTRY CAN CREATE A STANDARDIZED CARD AND PLACE ON ALL VESSELS
- SIGNAL LAMP/SEARCH LIGHT - *EXEMPT/WAIVE CONDITONAL CAT. 4 WATERS*
- WIRE CUTTING EQUIPMENT FOR USE IN THE EVENT OF DISMASTING (SAILING VESSELS ONLY)
- RADAR REFLECTOR - *EXEMPT/WAIVE CONDITONAL CAT. 4 WATERS*
- SAFETY HARNESS - *EXEMPT/WAIVE CONDITONAL CAT. 4 WATERS*
- ADEQUATE FIRST AID KIT
- SOLAS TABLE - *EXEMPT/WAIVE CONDITONAL CAT. 4 WATERS*
- LOG BOOK - *EXEMPT/WAIVE CONDITONAL CAT. 4 WATERS*
