**MERCHANT SHIPPING ACT, 2001

**Merchant Shipping (Adoption of United Kingdom
Enactments) Order, 2005**

[Gazetted 26th May, 2005]

The Governor in Council, after consultation with the Secretary of State for Transport of the United Kingdom and in exercise of the powers conferred by section 464 of the Merchant Shipping Act, 2001 (No. 13 of 2001), makes the following Order:

- Citation. **1.** This Order may be cited as the Merchant Shipping (Adoption of United Kingdom Enactments) Order, 2005.
- Interpretation. **2.** In this Order,
- Schedule “adopted enactment” means a United Kingdom enactment mentioned in Part II of the Schedule and includes any amendments made thereto before or after the commencement of this Order;
- “adopted provision” means a provision of an adopted enactment and includes any amendments made thereto before or after the commencement of this Order;
- “relevant modifications”, in relation to an adopted provision referred to in section 4(1), means such of the modifications specified in Part I of the Schedule as are relevant in all the circumstances of the case;
- No. 13 of 2001 “the Act” means the Merchant Shipping Act, 2001.

Schedule **3.** (1) Subject to subsection (2), section 4 and the modifications set out in Part I of the Schedule, the United Kingdom enactments mentioned in Part II of the Schedule are adopted as law of the Virgin Islands.
- (2) If an adopted enactment is, at any time after this Order comes into force, by any law of the United Kingdom extended so as to apply to the Virgin Islands or to Virgin Islands ships, as the case may be, and whether or not subject

to any modification specified in that law, subsection (1) shall cease to have effect in respect of that adopted enactment as soon as that law of the United Kingdom by its terms comes into force in relation to the Virgin Islands or Virgin Islands ships, as the case may be.

4. (1) This section has effect where an adopted provision is, after the coming into force of this Order,

Automatic application of certain repealing and amending enactment having effect in the United Kingdom.

- (a) amended;
- (b) repealed;
- (c) repealed and replaced; or
- (d) indirectly amended, that is to say, other than by way of change in the text of the adopted provision,
 - (i) modified or extended in its application so as not to be applicable in circumstances in which it previously applied; or
 - (ii) modified or extended so as to be applicable in circumstances in which it previously did not apply.

(2) Where the adopted provision is amended in the United Kingdom, the amendments shall have effect in the Virgin Islands, or in relation to Virgin Islands ships, as the case may be, subject to the relevant modifications, when they have effect in the United Kingdom or in relation to United Kingdom ships, as the case may be.

(3) Where the adopted provision is repealed in the United Kingdom, the adopted provision ceases to have effect in the Virgin Islands or in relation to Virgin Islands ships, as the case may be, at the same time as the repeal takes effect in the United Kingdom or in relation to United Kingdom ships, as the case may be.

(4) Where the adopted provision is replaced in the United Kingdom by another provision of law, the latter provision, subject to the relevant modifications, has effect in the Virgin Islands or in relation to Virgin Islands ships, as the case may be, at the same time as it has effect in the United Kingdom or in relation to United Kingdom ships, as the case may be.

(5) Where the adopted provision is indirectly amended in the manner mentioned in subsection (1)(d), the modifications or extensions, subject to the relevant modifications, have effect in the Virgin Islands or in relation to Virgin Islands ships, as the case may be, at the same time as they have effect in the United Kingdom or in relation to United Kingdom ships, as the case may be.

SCHEDULE

[Section 3(1)]

ADOPTION OF UNITED KINGDOM ENACTMENTS

PART I

GENERAL MODIFICATIONS TO ADOPTED ENACTMENTS

1. Every reference to a “United Kingdom ship” is to be construed as a reference to a Virgin Islands ship.
2. There shall be omitted every reference to Northern Ireland or Scotland and every provision relating solely to Northern Ireland or Scotland.
3. Every reference to England and Wales is to be construed as a reference to the Virgin Islands.
4. Every reference to the High Court, including the Crown Court, is to be construed as a reference to the High Court in the Virgin Islands.
5. Where an offence under an adopted enactment is, in England, punishable in a specified manner, it shall in the Virgin Islands, be triable summarily in the Magistrate’s Court and punishable in the same manner as the same offence is punishable on indictment in England and any lower punishment specified in relation to summary trial in England shall, in the Virgin Islands, be applicable in respect of summary trial of the offence before the Magistrate’s Court and such Court shall have the like jurisdiction in the Virgin Islands as the High Court or a Magistrate’s Court respectively in England would have in relation to the like offence.
6. Every reference to an offence being punishable by a fine is to be construed as meaning that that offence is punishable by a fine not exceeding level 5 on the standard scale of fines in Schedule 5 of the Act.

7. Every reference, other than in a provision enabling the making of any Order, regulation, rule or other subordinate legislation, to a Secretary of State, the Board of Trade, the Department of Transport or to a Minister shall be construed as a reference to the Minister.

8. Every provision providing that proceedings for an offence may not be commenced except by or with the consent of the person or persons specified in that provision is to be construed as if the only person therein specified were the Attorney General of the Virgin Islands.
